2. I submit that with regard to your second query about PG courses affiliation letter Rc. No: C-III(3)/SVA.Govt.DC/PG/2017-18 dated 22/06/2017 of Registrar, S.V. University, Tirupati our S.V.A. Govt. College, Srikalahasti has received permission for 11 (Eleven) PG courses. Due to lack of admissions in M.Sc., Chemistry, M.Sc., Statistics and M.A. Telugu courses were not run for the academic year 2017-18. Hence, for the academic year 2017-18, only 08 (Eight) PG courses have run. Hence, for the 08 (Eight) PG courses only we have requested the S.V. University for rectification and re-issue of the Affiliation Certificate.

Further, I am to bring to your kind notice that in the current academic year 2018-19 we have wound up the M.A. Economics course. Thus we are running 07 (Seven) PG courses only for this academic year. In our letter to The Registrar, S.V. University, Tirupati Rc. No. 5 Spl./2018-19, Dated 27.11.2018 we have requested to grant affiliation for 07 (Seven) PG courses only. Thus, I have paid the affiliation and inspection fee for 07 (Seven) PG courses only. Accordingly, I have revised the IIQA and Self Declaration by mentioning 07 (Seven) PG courses only.
